

Papers of Captain John Charles Fanshawe Royle [1884-1973] M.A.

Educated at Wellington and Christ Church, Oxford, John Royle was called to the Bar in 1912. After civilian work, he joined the Inns of Court O.T.C. in 1918 and became an Acting Captain in the R.A.O.C. in 1919.

In 1915, he married Amy Mabel the widow of James Cavan and went to live at her home Eaton Mascott Hall in Shropshire. In 1919, the family moved to Youlston Park, near Barnstaple, in Devon. Captain Royle appears not to have practised as a lawyer and led the life of a country gentleman running the estate and being involved in local affairs particularly as a J.P. and participating in the North West Devon Conservative Association.

Essentially what is offered here is an archive featuring two families, the Royle family from Cheshire, and the Cavan family who were merchants and ship owners with roots in Scotland, Ireland and the West Indies. Much of the archive reflects life in two country houses: Eaton Mascott Hall and Youlston Park.

JAMES CAVAN [1771-1859]. 'Diary and Expenditure of James Cavan from 7 2. September 1824 the day he landed at Falmouth on 'Osborne' to 20 March 1825 when he returned to London from Paris. Made up by P.C. Cavan 20 April 1859'. As titled on envelope. It is an interesting record of a merchant's personal spending and his journeying on returning to Europe. James Cavan was born at Kirkmaiden in Wigtownshire. He went to Barbados in 1797. He was in partnership with his brother Michael and following his death became the principal partner of Cavan Bros & Co, described as West India and East India Merchants. He was one of the founders of the Colonial Bank and the Royal Mail Steam Packet Company. At his death, his estate was stated to be worth £500,000, but this was later resworn to $f_{,300,000}$.

3. CAVAN BROTHERS. MICHAEL CAVAN [died 1832]

Abstract of Will with codicils, 3pp, list of bequests, to family, friends and servants, residue to James Cavan, with notes on how and when paid. *Tears on folds*. Another copy. Sold with folio, 6pp, in ink. James Neil Esq Account with Michael Cavan & Co, 1829, totalling £87,583. The chief transaction seems to relate to a draft for £75,000 (see above), but the main part of the account is for smaller expenses, attorneys, taxes, freight of books to New York, freight of mules and asses to Trinidad, rum, wine, madeira, wine glasses, pair of coaches, linen, cashmere, Castile soap, charcoal, paving slabs, blacksmith's work, etc

And two letters from John Torrance [b.1805], a partner in Cavan Brothers, of Stranraer about the death of his mother, Mrs Margaret Torrance, and how her affairs will be settled 1851. (Both were legatees of Michael Cavan) **£85**

Many of the bequests were to fellow partners of Cavan Bros and their children. In many cases there are details of the birth dates of legatees. The first mentioned legatee to whom was left £5,000 is Louisa Keeling apparently a 'free woman of colour' who lived in Broad Street, Bridgetown, Barbados. In 1829, she owned 12 slaves.

According to the UCL Legacies of British Slavery database, James Neil was Michael Cavan's nephew who he disinherited because of his conduct towards Cavan's brother James. (In this abstract his legacy of £5000 is marked 'revoked'.) In 1836, James Neil is listed as an unsuccessful claimant in connection with Apes Hill estate. Margaret Torrance was the sister of Michael and James Cavan.

Philip Cavan, born in Guadaloupe, was the son of James Cavan. He had a dual career in the family firm of merchants and as a soldier. He was Ensign in 1834 in the 30th regiment and reached Lt Colonel in 1853, retiring from the army in the same year, apparently by purchase. He married in 1855 Mary, born in County Cork, the daughter of Sackville Berkeley. On the death of his father in 1859, he became the major shareholder in Cavan Brothers.



in 1851. On 18th April 1838, when on patrol as an anti-slaver, she took the slaver Diligente as part of Britain's part of her treaty with Spain for the suppression of the slave trade. Paget joined the navy in 1827. Having reached the rank of Commander 25 Sept, he commanded, the Pearl from 1837-39, on the North America and West India station.

This summary shows their income was derived mostly from commission, but also interest, shipping, charters, shares and bonds including Sagua la Grande Railway Bonds. Their costs were business expenses, losses on bonds and adventures including resin warrants, and bad debts mostly in the UK, Barbados, (particularly to the Colonial Company), but also in Smyrna, Constantinople and Egypt (Societe Agricole shares) **£650**

These accounts give a detailed overview of the business's activities, which were conducted all over the world and included shipping and railways, but were mostly concentrated in the West Indies including British Guiana. They seem to have had a web of business interests including being proprietors of estates but also offering other services such as banking, mortgages, loans and insurance. P.C. Cavan was the largest shareholder. The major assets were the shares in the Colonial Company and the largest liability the

partners' accounts. The offices were at 16 Leadenhall Street, London. Nevile Lubbock [1839-1914] joined Cavan Brothers in 1862. These accounts would appear to be connected with the transformation of Cavan Lubbock & Co into the Colonial Company Ltd which lasted until 1901. They offer a chance to study the profitability and management of these West Indian estates after the abolition of slavery.

The principal sums were repaid in 1885. In 1884 it would appear the debentures were worth f_{2} 41,860. The works were started in 1798. This particular company was formed in 1872. It would appear Mary Cavan held nearly one third of the shares in The Llynvi Coal and Iron Company in 1871. Her husband Colonel Cavan had died in 1870. The Cavan family had a long history of investing in the South Wales iron industry. James Cavan had invested in the Llynvi Iron Works in 1845 and before that in the Cambrian Iron and Spelter Company.

In 1886 the company's ironworks at Maesteg ceased to work. Possibly the paying back of the debentures was a contributing factor to the closure.

This rich widow was evidently generous, bestowing extravagant gifts on Grossmith himself and his family. Although George Grossmith is probably best known as the interpreter of roles in Gilbert and Sullivan operas and as the co-author of Diary of a

known as the interpreter of roles in Gilbert and Sullivan operas and as the co-author of 'Diary of a Nobody', he also performed on his own an entertainment of sketches and songs, while playing at the piano. These events were performed at London and provincial theatres and for clubs and institutions, but he also developed a business entertaining at private society parties. He called his autobiography 'A Society Clown' (1888) and claimed if invited out to dinner, 'any hostess who asked me to her residence in the expectation that I should gratuitously amuse her guests would find me particularly prosaic'. Despite this protest, he evidently enjoyed these lucrative recitals at such parties, and presumably it was on one such occasion he met Mrs Cavan, who became a family friend.

Mrs Cavan had a house at Carshalton, but how did this letter come to be found with the letters to her? It seems hard to believe this letter was some sort of spoof sent deliberately to Mrs Cavan, as one of her daughters is referred to disparagingly. Among the series of letters above is one dated 16 August which commences I am very pleased to hear from Rosie that you have apologised for your disgraceful conduct to me and with an aching heart I consent to be friends again.' Which may indicate there had been some falling out between them, possibly connected with this letter.



EATON MASCOTT HALL, Berrington, Shropshire was rented by James Cavan at least as early as 1893. He built an observatory there. His wife Amy Mabel stayed there after his death in 1911. In 1915, she was remarried to John Charles Fanshaw Royle. The couple stayed there until after the First World War.





YOULSTON PARK, near Barnstaple, Devon had been in the Chichester family since it was built in 1516 and it was leased by Mrs Amy Royle in 1919. The following year, she purchased the freehold for £8,300 from Edward Chichester. Captain Royle probably left Youlston on his marriage to Barbara Chichester in 1951. In a *Country Life* article dated 1961 it is described as the home of Major Cavan and his sister Sylvia. In 1972, Captain Royle and Major Cavan agreed to sell the estate to J.S.C. Clark of Smythapark for £17,000 and the contents at Sotheby's valuation.

Insurance policies, Income tax and Super tax forms and correspondence, shares, including Escot Rubber, dividend vouchers, war loan. Over 30 used cheque books, bank book.

Legal documents, includes the lease of the Park 1921, correspondence concerning his mother's estate and her marriage settlement and his parents' wills.

Address books, 1949 diary, particulars for sale of Youlston Estate, 1920 with plan Papers concerning North West Devon Conservative Association, Barnstaple Division, and Conservative party rosette. Letter dated 1926 asking to be J.P. North Devon Infirmary subscriptions and correspondence Milk Book, 1944, employees N.I. record book,

Military documents and correspondence, leave passes, ration books, selection to Inns of Court OTC, 1918, and temporary commission as 2nd Lieutenant 6/11/1918. Commission as Lieutenant, 1921, medical examinations.

Wallet with British Museum library card, fishing licences, Bar Examination Law lecture notes, bar certificate, 1912, and his birth certificate.






